20. <u>SECONDARY PLANS</u>

(Chapter 20 added to Official Plan by OPA #501)

20.1 INTRODUCTION

Secondary Plan policies and schedules, adopted pursuant to Section 19.2.1 of this Plan, will provide guidance and direction for the review and consideration of planning applications for specific geographic areas of the City. These Secondary Plans will include policies and land use and other schedules developed through the planning process, and will be adopted through an Official Plan amendment. The lands subject to the policies of Chapter 20 are delineated on Schedule "D" – Planning Areas. Where warranted on the basis of a Secondary Plan review, lands may be added to Schedule "D" – Planning Areas through amendments to the Official Plan.

20.1.1 Identification of Secondary Plan Areas

Schedule A – Land Use, will identify general land use designations for lands within identified Secondary Plan areas. More specific land use designations and associated policies may be established through the Secondary Plan. Schedule "D" – Planning Areas, will identify those geographic areas that are subject to Secondary Plans.
